The Company and each of the Selling Shareholders (as defined hereinafter) propose to undertake an initial public offering of equity shares of face value of ₹ 1 each of the Company (“**Equity Shares**”) comprising of an offer for sale by the Selling Shareholders (the “**Offer**”), through the book building method as prescribed in Schedule XIII of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (“**SEBI ICDR Regulations**”) (“**Book Building Process**”), in accordance with the Regulation 45 of the Securities Contracts (Regulation) (Stock Exchanges and Clearing Corporations) Regulations, 2018, as amended (“**SECC Regulations**”), Companies Act, 2013, as amended, including any rules, regulations, clarifications and modifications thereto, each as amended (“**Companies Act**”), and other applicable laws at such price as may be determined or discovered based on the Book Building Process by the Company in consultation with the BRLMs (“**Offer Price**”). The Offer includes an offer (i) within India, to Indian institutional, non-institutional and retail investors in “offshore transactions”, as defined in, and in reliance upon, Regulation S under the United States Securities Act of 1933, as amended (the “**U.S. Securities Act**”) (“**Regulation S**”) and in compliance with the SEBI ICDR Regulations, (ii) in the United States to persons reasonably believed to be “qualified institutional buyers” (as defined in Rule 144A under the U.S. Securities Act (“**Rule 144A**”)) pursuant to Section 4(a) of the U.S. Securities Act, and (iii) outside India and the United States, to institutional investors in “offshore transactions”, as defined in, and in reliance upon, Regulation S and in each case, in compliance with the applicable laws of the jurisdiction where such offers and sales occur. In accordance with the SEBI ICDR Regulations, the Offer may also include allocation of Equity Shares on a discretionary basis to certain Anchor Investors by the Company in consultation with the Book Running Lead Managers (as defined hereinafter), and in accordance with Applicable Law.

The draft red herring prospectus of the Company dated June 17, 2026 (“**Draft Red Herring Prospectus**” or “**DRHP**”) along with the draft abridged prospectus dated June 17, 2026 (the “**DAP**”) in relation to the Offer is being filed herewith for your consideration and observations.

In connection with the filing of the DRHP with Securities and Exchange Board of India (“**SEBI**”), we hereby submit the following:

1. The soft copy of the (a) DRHP in “.PDF” format (**Annexure I**) as approved by the board of directors of the Company (“**Directors**”) and the IPO Committee, in their meetings held on June 15, 2026 and June 17, 2026, respectively, has been signed by (i) all the Directors; (ii) the Chief Financial Officer of the Company; and (iii) each of category B Selling Shareholders and PoA holder for category A selling shareholders, together with this letter and all annexures hereto; and (b) DAP, pursuant to the Securities

and Exchange Board India (Issue of Capital and Disclosure Requirements) (Amendment) Regulations, 2026, dated March 16, 2026, notified on March 18, 2026, in “.PDF” format (**Annexure II**) and has been uploaded on the SEBI intermediary portal at <https://siportal.sebi.gov.in>, as specified in Regulation 25(8) of the SEBI ICDR Regulations and chapter IV of the SEBI master circular no. SEBI/HO/49/14/14(2)2026-CFD-POD2/I/4518/2026 dated February 9, 2026 read with the SEBI directive dated October 14, 2022 issued to the Association of Investment Banker of India (“AIBI”) and has been filed with the BSE Limited by the Company as specified in Regulation 25(3) of the SEBI ICDR Regulations along with the in-principle application in relation to Offer, in compliance with “Guidelines for filings of Draft Offer Documents” dated July 25, 2024 issued by the Stock Exchange and Regulation 7(1)(a) of the SEBI ICDR Regulations. All online payments will be made in accordance with the instructions issued by SEBI on “Easing of Operational Procedure” dated August 11, 2021, SEBI circular no. SEBI/HO/GSD/TAD/CIR/P/2022/0097 dated July 18, 2022, and SEBI press release dated June 27, 2023.

2. A certificate from the BRLMs confirming that the Company, the Selling Shareholders and the BRLMs have entered into an Offer Agreement dated June 17, 2026 (including the statement of *inter se* allocation of responsibilities of the BRLMs), in accordance with Regulations 23(5) and 25(2)(a) and the format specified in Schedule II of the SEBI ICDR Regulations (**Annexure III**);
3. A due diligence certificate dated June 17, 2026 signed by the BRLMs in accordance with Regulation 25(2)(b) of the SEBI ICDR Regulations (**Annexure IV**), along with (i) a due diligence process note as required under Form A of Schedule V of the SEBI ICDR Regulations (**Annexure IV-A**); (ii) a detailed checklist confirming regulation-wise compliance of the disclosures in the DRHP with the applicable provisions of the SEBI ICDR Regulations (**Annexure IV-B**) and (iii) a detailed checklist indicating item-wise compliance with the additional confirmations and disclosures to be provided in terms of the directive dated May 29, 2024, which was further updated on June 24, 2024, issued by SEBI to AIBI (**Annexure V**);
4. In connection with the Offer, the Company will make payment towards filing fees, along with Goods and Services Tax (“GST”) and transaction charges, if any, basis the e-challan generated on the SEBI’s intermediary portal towards the DRHP filing fees as provided under Schedule III of the SEBI ICDR Regulations. Details of the filing fees, along with GST shall be intimated to SEBI separately.

In connection with the Offer, please note the following:

A. *The Company does not have any identifiable promoters*

The Company is a professionally managed company and does not have an identifiable promoter in terms of the SEBI ICDR Regulations and the Companies Act, 2013. Relevant disclosures in this regard have been included in the DRHP.

B. *Confirmation in relation to directors associated with the securities market*

None of the directors are associated with the securities market in any capacity other than them being a director of the Company, which is a recognised stock exchange.

C. *Securities and Exchange Board of India no objection letter to Company in relation to the listing of Company’s securities*

The Company, being a recognized stock exchange, is governed by various regulations issued by the SEBI including the Securities Contracts (Regulation) (Stock Exchanges and Clearing Corporations) Regulations, 2018, as amended (the “SECC Regulations”). Regulation 45 of the SECC Regulations, amongst others, requires stock exchanges to obtain the approval of SEBI for undertaking listing of its

securities. In relation to the Offer, SEBI, pursuant to its letter dated January 30, 2026 (“**SEBI NoC Letter**”), has permitted the listing of Equity Shares on a recognised stock exchange, subject to the following conditions: (i) strict compliance with the SEBI (SECC) Regulations, 2018, and all relevant circulars governing the listing of Market Infrastructure Institutions; (ii) Company undertaking all necessary measures to ensure that its entire shareholder base consistently satisfies the “fit and proper” criteria and shareholding limits prescribed under the SECC Regulations, 2018; (iii) Offer Documents containing comprehensive disclosures regarding all technical glitches occurring in the past three years including details of any financial disincentives or penalties levied by SEBI; (iv) Company disclosing all pending or concluded enforcement actions initiated by the regulator, including need for provisioning, if any, regarding matters that are sub judice; (v) filing of Offer Documents and the subsequent issuance process strictly adhering to the SEBI ICDR Regulations; and (vi) the entire listing process being concluded within one year from the date of issuance of the SEBI NoC Letter. The aforesaid SEBI NoC Letter shall remain valid until January 30, 2027.

D. Employee Reservation Portion and discount for eligible employees

Pursuant to Regulation 33 of the SEBI ICDR Regulations, the Offer may include an Employee Reservation Portion, the details of which shall be finalised prior to filing of the Red Herring Prospectus. The Employee Reservation Portion shall not exceed 5% of the post-Offer paid up Equity Share capital of the Company in accordance with Regulation 33(2) of the SEBI ICDR Regulations. Accordingly, the details of the Offer structure will be disclosed in the Red Herring Prospectus, post finalisation of such reservation, if any.

Further, a discount to the Offer Price may be offered to the Eligible Employees Bidding in the Employee Reservation Portion, in accordance with the SEBI ICDR Regulations. The particulars of such discount (if any) will be suitably updated in the price band advertisement to be announced prior to the Bid/ Offer Opening Date.

SCHEDULE V

DETAILS OF SECURITIES LAW VIOLATIONS

I. The Company

- SEBI issued show cause notices dated May 22, 2017 and July 3, 2018, and a supplementary show cause notice dated July 31, 2018 (collectively, “SCNs”), under Sections 11(1), 11(2)(a), 11(2)(j), 11(4) and 11B of the SEBI Act and Section 12A of the SCRA and Regulation 49 of the SECC Regulations, against the Company and others (“**Notices**”), alleging, among others, violation of Regulations 3(a), (b), (c) and (d) and 4(1) of the SEBI PFUTP Regulations read with Sections 12A(a), (b) and (c) of the SEBI Act, Regulations 41(2), 42(2) of the SECC Regulations, Clause 4(i) of the SEBI Circular CIR/MRD/DP/09/2012 dated March 30, 2012 and Clause 3 of the SEBI Circular CIR/MRD/DP/07/2015 dated May 13, 2015, in relation to among others, allegations of preferential access and early connection to certain trading members in the Company’s tick-by-tick architecture in the colocation facility and non-cooperation by the Company and the Company’s officials in the forensic review of the colocation facility by forensic auditor. The Company responded to the SCNs through its reply dated November 20, 2018, denying the allegations under the SCNs. Subsequently, the learned Whole-Time Member of the SEBI through an order dated April 30, 2019, under Sections 11 and 11B of the SEBI Act (“**WTM Order**”) directed the Company among others, to disgorge an amount of ₹ 6,248.90 million along with interest at 12% p.a. from April 1, 2014, till the date of payment and certain non-monetary and restrictive directions including prohibiting the Company from accessing the securities market for a period of six months from the date of the WTM Order. However, SEBI found that the Company did not violate the provisions of the SEBI PFUTP Regulations. The Company preferred an appeal dated May 19, 2019 (“**SAT Appeal I**”) before the SAT challenging the WTM Order. The SAT, through an order dated January 23, 2023 (“**SAT Order I**”), partly allowed SAT Appeal I, set aside the

SEBI directive for disgorgement and further held that the Noticees were not in violation of Regulations 41(2) and 42(2) of the SECC Regulations and directed the Company to deposit ₹ 1,000.00 million in the Investor Education and Protection Fund. Separately, SEBI issued an adjudication notice dated January 4, 2019, under Rule 4(1) of the SEBI Adjudication Rules read with Section 15-I of the SEBI Act and Rule 4(1) of the SCRR Adjudication Rules against the Company, alleging, among others, violations of the SECC Regulations, the SEBI PFUTP Regulations and certain circulars issued by SEBI, pursuant to which an order dated February 10, 2021 (“**Adjudication Order**”) was passed imposing a penalty of ₹10.00 million on the Company. The Company preferred an appeal dated February 24, 2021 (“**SAT Appeal II**”) before the SAT challenging the Adjudication Order. The SAT, through an order dated July 12, 2023 (“**SAT Order II**”), set aside the Adjudication Order. Aggrieved by SAT Order I and SAT Order II, the SEBI filed an appeal dated February 27, 2023 (“**Appeal I**”), and September 13, 2023 (“**Appeal II**”), under Section 15Z of the SEBI Act, before the Supreme Court of India, challenging SAT Order I and SAT Order II, respectively. The Supreme Court of India through an order dated March 20, 2023, directed SEBI to refund a sum of ₹3,000.00 million to the Company, subject to furnishing of an undertaking that in case Appeal I is allowed, the Company will repay the amount along with interest. The Supreme Court of India, through an order dated October 30, 2023, tagged Appeal I and Appeal II together (“**SC Appeals**”). During the pendency of the SC Appeals, the Company filed a settlement application dated June 20, 2025 (“**Settlement Application**”) for an amount of ₹11,647.30 million with SEBI seeking settlement of the WTM Order and the Adjudication Order. Subsequently, the Company filed revised settlement terms on March 13, 2026 for an amount of ₹12,235.59 million. The matters and the Settlement Application are currently pending.

- SEBI issued show cause notices dated May 22, 2017 and July 3, 2018 (collectively, “**SCNs**”), under Sections 11(1), 11(2)(a), 11(2)(j), 11(4) and 11B of the SEBI Act and Section 12A of the SCRA, against the Company and others, alleging, among others, violations of Regulations 3(d) and 4(1) of the SEBI PFUTP Regulations read with Section 12A(c) of the SEBI Act, Regulation 41(2) of the SECC Regulations, Clause 4(i) of the SEBI Circular CIR/MRD/DP/09/2012 dated March 30, 2012, Clause 3 of the SEBI Circular CIR/MRD/DP/07/2015 dated May 13, 2015, non-implementation of the decision of the secondary market advisory committee dated November 11, 2011 and communicated to the Company through email dated November 28, 2011, allegations of preferential treatment to certain trading members to avail point-to-point connectivity through an unauthorised service provider, non-transparent mode of communication to stock brokers and conferring unfair latency advantage. The Company responded to the SCNs in its reply dated February 25, 2019, denying the allegations under the SCNs. Subsequently, the learned Whole-Time Member of the SEBI through an order dated April 30, 2019 (“**WTM Order**”), under Sections 11 and 11B of the SEBI Act directed the Company among others, to disgorge an amount of ₹625.80 million along with interest at 12% p.a. from September 11, 2015, till the date of payment, to audit every six months the network architecture and infrastructure in its colocation facility by an independent CISA/CISM qualified and CERT-IN empaneled auditor and to submit a report duly certified by the managing director and chief executive officer certifying that the network architecture and connectivity at its colocation facility and its linkages to the trading infrastructure are in conformity with the SEBI’s regulatory norms. The Company preferred an appeal dated May 19, 2019 (“**SAT Appeal I**”) before the SAT challenging the WTM Order. The SAT, through an order dated August 9, 2023 (“**SAT Order I**”), partly allowed SAT Appeal I and set aside the SEBI directive for disgorgement. Separately, SEBI issued an adjudication notice dated December 13, 2018, under Rule 4(1) of the SEBI Adjudication Rules read with Section 15-I of the SEBI Act and Rule 4(1) of the SCRR Adjudication Rules against the Company, alleging, among others, violation of the SEBI Act, the SCRA, the SECC Regulations, the SEBI PFUTP Regulations and certain circulars issued by SEBI, pursuant to which an order dated June 28, 2022 (“**Adjudication Order**”) was passed imposing a penalty of ₹70.00 million on the Company for the above alleged violations. The Company preferred an appeal dated July 21, 2022 (“**SAT Appeal II**”) before the SAT challenging the Adjudication Order. Consequently, SAT through an order dated December 14, 2023 (“**SAT Order II**”), set aside the Adjudication Order. Aggrieved by SAT Order I and SAT Order II, the SEBI filed an appeal dated September 5, 2023 (“**Appeal I**”), and February 12, 2024 (“**Appeal II**”), under Section 15Z of the SEBI Act, before the Supreme Court of India, challenging SAT Order I and SAT Order II, respectively. The Supreme Court of India through an order dated October 17, 2023, directed SEBI to refund a sum of ₹ 310.00 million to the Company, subject to furnishing an undertaking that in case Appeal I is allowed, the Company will

repay the amount along with interest. The Supreme Court of India, through an order dated April 10, 2024, tagged Appeal I and Appeal II together (“**SC Appeals**”). During the pendency of the SC Appeals, the Company filed a settlement application dated June 20, 2025 (“**Settlement Application**”) for an amount of ₹2,226.60 million with SEBI seeking settlement of the WTM Order and the Adjudication Order. Subsequently, the Company filed revised settlement terms on March 13, 2026 for an amount of ₹2,676.48 million. The matters and the Settlement Application are currently pending.

3. SEBI issued a show cause notice dated January 7, 2021, under Rule 4(1) of the SEBI Adjudication Rules read with Section 15-I of the SEBI Act (“**SCN**”), against the Company in connection with an inspection into the operations of Karvy Stock Broking Limited (“**KSBL**”), alleging that the Company, among others, (i) did not examine the demat account through which securities of clients of KSBL were wrongly pledged with banks / financial institutions and funds raised by pledging of client securities were credited to KSBL’s own accounts; and (ii) failed to tag demat accounts in the prescribed nomenclature, together resulting in violation of various circulars issued by the SEBI. The Company responded to the SCN through its reply dated February 23, 2021, submitting that the Company discharged its obligation to conduct due diligence properly and adequately and that non-sharing of pledge related information promptly was on account of a SEBI circular. Subsequently, SEBI issued a supplementary show cause notice dated May 6, 2021 (“**Supplementary SCN**”), alleging that the Company had failed to take appropriate action in relation to various alerts pertaining to off-market transfers. The Company responded to the Supplementary SCN through its reply dated June 1, 2021, challenging its maintainability on the grounds that it was issued on a post facto basis and that the Company while discharging its quasi-regulatory oversight functions, cannot be held liable for the misconduct of the intermediary, in the absence of any *mala fides*. Thereafter, SEBI through its adjudication order dated April 12, 2022 (“**Adjudication Order**”), levied a penalty of ₹20.00 million under Section 15HB of the SEBI Act, on account of alleged lapses on the part of the Company, resulting in delayed detection of the misconduct by KSBL. The Company preferred an appeal dated May 27, 2022 (“**Appeal**”) before the SAT, seeking to quash and set aside the Adjudication Order and to stay its operation pending final disposal of the Appeal. The SAT, through an order dated June 24, 2022, stayed the effect and operation of the Adjudication Order. SEBI filed its reply to the Appeal on September 7, 2022, pursuant to which the Company filed a rejoinder dated December 2, 2022. The matter is currently pending.
4. SEBI issued a show cause notice dated July 31, 2020 (“**Adjudication Notice**”), against the Company, under Rule 4 of the SEBI Adjudication Rules alleging violations of Regulations 38(2) and 41(3) of the SECC Regulations, alleging, among others, that the Company had engaged, directly and/or through NSE Investments Limited (*formerly known as NSE Strategic Investment Corporation Limited*), its wholly owned subsidiary, in activities unrelated or non-incidental to a stock exchange without having obtained SEBI’s approval as required under Regulations 38(2) and 41(3) of the SECC Regulations. The Company responded to the Adjudication Notice through a reply dated September 7, 2020 setting out that our investments in the aforementioned entities are not impacted by Regulation 41(3) of the SECC Regulations. SEBI through an order dated October 1, 2020 (“**SEBI Order**”), levied a penalty of ₹60.00 million on the Company. The Company preferred an appeal dated November 10, 2020, before the SAT against the SEBI Order, which through an order dated January 4, 2022 (“**SAT Order**”), set aside the SEBI Order. SEBI preferred an appeal dated March 2, 2022 (“**Appeal**”) against the SAT Order before the Supreme Court of India, to which the Company filed a counter-affidavit dated April 25, 2022, seeking the dismissal of the Appeal. The matter is currently pending.

All capitalized terms used herein and not specifically defined shall have the same meanings ascribed to such terms in the DRHP.

In connection with the Offer, Cyril Amarchand Mangaldas has been appointed as legal counsel to the Company as to Indian Law, Khaitan & Co has been appointed as domestic legal counsel to the BRLMs as to Indian law, Latham and Watkins LLP has been appointed as international legal counsel to the Company and Sidley Austin Singapore Pte. Ltd. has been appointed as international legal counsel to the BRLMs (collectively, “Legal Counsels”). The Legal Counsels have assisted the BRLMs in carrying out due diligence and drafting of the DRHP in compliance with the SEBI ICDR Regulations and other applicable laws and advising the Company and the BRLMs, in relation to the Offer, including for the purpose of issuing legal opinions in relation to the Offer to the BRLMs, as applicable.

The due diligence process commenced with interactions with the representatives of the Directors, Key Managerial

Personnel (including the Chief Financial Officer), members of Senior Management and other representatives of the Company for gaining an understanding, amongst other matters, of the business of the Company, its Subsidiaries, its Associates, key risks involved, industry overview, financial overview and the background of the management of the Company, its Subsidiaries and its Associates. These interactions were conducted with the objective of assisting the Company in preparing the necessary disclosures as required under the SEBI ICDR Regulations and other applicable laws in relation to the Offer. In this regard, the Company was provided with a due diligence questionnaire and information requisition lists prepared in consultation with the Legal Counsels. In response to the questionnaire and the requisition lists, the Company provided supporting documents for review and diligence and gave clarifications and explanations for queries raised. In order to facilitate such review, the Company set up a virtual data room where copies of such relevant documents were made available for undertaking the due diligence.

The BRLMs were also assisted by the statutory auditors of the Company, namely Price Waterhouse & Co, Chartered Accountants, LLP (“**Statutory Auditors**”), for financial due diligence. The Statutory Auditors have verified details and provided certifications with respect to certain other financial information included in the DRHP including the computation of Company’s revenue, net worth, profit for the period, net asset value, etc. and provided an examination report dated June 8, 2026 in relation to the Restated Consolidated Financial Information. Further, Manian & Rao, Chartered Accountants (FRN No. 001983S) (“**Independent Chartered Accountant**”) have verified and provided certifications with respect to certain financial, operational and other information included in the DRHP. As on the date of the DRHP, the Statutory Auditors and the Independent Chartered Accountant have confirmed that they hold valid peer review certificates issued by the peer review board of the Institute of Chartered Accountants of India.

The BRLMs have obtained and relied on a certification provided by RBSA Advisors LLP, duly registered as chartered engineer with the Institution of Engineers (India) with membership no. M-145539-1. The independent chartered engineer has confirmed certain information pertaining to the Company’s business and its technology platform.

The BRLMs have also obtained and relied on a certification provided by R K Dewan & Co., an intellectual property consultant. The intellectual property consultant has confirmed information in relation to the registered and pending intellectual property, namely: (i) trademarks; (ii) patents; (iii) copyrights; (iv) domain names of the Company and the Subsidiaries of the Company.

In addition, BRLMs were also assisted by Makarand M. Joshi & Co., acting in their capacity as practicing company secretary, (“**Practicing Company Secretary**” or “**PCS**”) from whom certifications were obtained on *inter-alia* (i) statutory registers; (ii) compliance of the articles of association of the Company with the Companies Act, 2013; (iii) the share capital build-up of the Company and compliance with the Companies Act, 2013; and (iv) structured digital database.

Each of the Statutory Auditors, the Independent Chartered Accountant, the independent chartered engineer and intellectual property consultant and the PCS has consented to be named as an expert, in terms of the Companies Act, 2013, in the DRHP and such consents have not been withdrawn as at the date of filing of the DRHP with the SEBI.

The Company has placed reliance on the industry report titled “*Capital Markets and Market Infrastructure Institutions in India*” dated June 16, 2026 issued by Redseer Strategy Consultants Private Limited (“**Redseer**”), exclusively commissioned and paid for by the Company pursuant to the engagement letter dated March 16, 2026 (such report, “**Redseer Report**”), for disclosures in relation to industry information in the DRHP. Further, the Company has received a written consent from Redseer dated June 16, 2026 to include the Redseer Report in the DRHP and as a material document for inspection by the public in the section titled “*Material Contracts and Documents for Inspection*” of the DRHP and will be available on the website of the Company at <https://www.nseindia.com/static/investor-relations/offer-documents>.

1. Business and Commercial Diligence

The due diligence process in relation to general business and commercial matters included:

Where arrangements with customers and vendors were numerous and/or in standard form, the review was undertaken on a sample basis, having regard to the relevant contribution of such arrangements to revenue or expenses, including, where applicable, by reference to top customers in the relevant business segment and critical vendors identified by the Company, for the purpose of verifying the related disclosures in the DRHP. In relation to properties, the review extended to the identified property documents, including those relating to the Registered and Corporate Office, offices of subsidiaries, regional offices, data centres, selected ISC centres and the windmill, and agreements entered into with landlords in relation to leased properties were reviewed on a sample basis in accordance with the property diligence approach.
- (j) Obtaining and relying on comfort letters on tick-and-tie circle-up confirmations from the Statutory Auditors on the Restated Consolidated Financial Information as well as on certain financial information included in the DRHP, in each case, as of and for the periods specified therein.
- (k) For certain information, relying on management certificates from the Company for ensuring compliance with the SEBI ICDR Regulations and making disclosures in the DRHP in this regard.
- (l) Obtaining (i) circle up confirmations and certificates from the Statutory Auditors in accordance with SEBI ICDR Regulations on the financial information included in the DRHP, and (ii) circle-ups and certificates from the Independent Chartered Accountant, on certain key performance indicators, operational data and certain financial related information included in the DRHP.
- (m) Obtaining the approval of the Audit Committee of the Company with respect to disclosures on the key performance indicators of the Company included in the "Basis for Offer Price" section of the DRHP, in accordance with the SEBI ICDR Regulations.
- (n) Obtaining and relying on formal representations and undertakings from the Company.
- (o) Reviewing such other documents as we have deemed necessary and as have been provided to us by the Company, from time to time.

2. Financial Information of the Company and Financial Indebtedness

Due diligence was conducted on financial matters, which included due diligence calls with the Statutory Auditor, and Independent Chartered Accountant, and discussions with the Chief Financial Officer of the Company. The restated consolidated financial information of the Company comprise of restated consolidated financial information of the Company, the Subsidiaries and the Associates as at and for the financial years ended March 31, 2026, March 31, 2025 and March 31, 2024, which comprises the restated

Further, the Statutory Auditors were required to review the restated consolidated financial information as included in the DRHP and have delivered customary comfort letters and circle-ups to the BRLMs. Such comfort letters will be issued and/or brought down at certain future dates as the Offer progresses, by the statutory auditor, including on the date of the RHP, the Prospectus and the Allotment of Equity Shares in the Offer.

Further, the Independent Chartered Accountant also assisted the BRLMs by verifying and providing certifications in relation to, amongst others, eligibility of the Company to undertake the Offer, details of any outstanding dues owed to micro and small enterprises, material creditors and other creditors of the Company, remuneration of Directors, Key Managerial Personnel and Senior Management, basis for Offer Price and certain key performance indicators of the Company disclosed in the DRHP. The Independent Chartered Accountant has also confirmed that related party transactions of the Company have been entered into in accordance with applicable laws on an arm's length basis. The Independent Chartered Accountant has also confirmed the non-applicability of (i) Securities and Exchange Board of India (Framework for Rejection of Draft Offer Documents) Order, 2012; (ii) Securities and Exchange Board of India (Issuing Observations on Draft Offer Documents Pending Regulatory Actions) Order, 2020 and (iii) Securities and Exchange Board of India (Prohibition on Raising Further Capital from Public and Transfer of Securities of Suspended Companies) Order, 2015, to the DRHP and/or Offer. Reliance was also placed on the statement of special tax benefits available to the Company and its Shareholders and its Material Subsidiary, NSE Clearing Limited issued by the Independent Chartered Accountant.

For the purposes of the DRHP, a diligence exercise of outstanding financial indebtedness of the Company was conducted, and such information has been disclosed in a summarised form in the DRHP. In this connection, the relevant financing related documents were reviewed. Reliance was also placed on certification obtained from the Independent Chartered Accountant in connection with the financial indebtedness of the Company and ascertaining the amount of outstanding borrowings of the Company as of March 31, 2026 which has been disclosed in the section titled "*Financial Indebtedness*" in the DRHP.

In addition, the Company has uploaded on its website, the audited standalone financial statements of the Company, and its Material Subsidiaries, i.e., NSE Clearing Limited and NSE Investments Limited, as per SEBI ICDR Regulations, for the Financial Years ended March 31, 2026, March 31, 2025 and March 31, 2024 and the annexures, schedules and reports thereto.

3. *Basis for Offer Price and Key Performance Indicators*

SEBI on November 21, 2022 (and published in the Official Gazette on November 23, 2022), introduced certain amendments to the SEBI ICDR Regulations *vide* the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) (Fourth Amendment) Regulations, 2022 notified by the SEBI on November 21, 2022 read with the SEBI circular dated February 28, 2025 on '*The Industry Standards on Key Performance Indicators ("KPIs") Disclosures in the draft Offer Document and Offer Document*'. In compliance with the same, suitable disclosures have been made in relation to key performance indicators of the Company in the section titled "*Basis for Offer Price*" and other relevant sections in the DRHP. In accordance with the Materiality Policy, all outstanding litigation involving the Relevant Parties which exceeded an amount equivalent to ₹ 3,320.26 million (“**Materiality Threshold**”), being the amount equivalent to 2.00% of turnover, for the most recent financial year as per the Restated Consolidated Financial Information i.e., Fiscal 2026, would be considered ‘material’. Further, the following outstanding litigation including civil legal proceedings and arbitration matters, shall also be considered ‘material’ litigation’ in

As required under the no-objection letter dated January 30, 2026, issued by SEBI, a summary of the enforcement actions previously undertaken by SEBI against the Company, have been disclosed in a tabular format under the section titled “*Outstanding Litigation and Material Developments- Details of resolved enforcement actions previously undertaken by SEBI against the Company*” on page 407 of the Draft Red Herring Prospectus.

The Company provided a list of outstanding litigation involving the Company and the Subsidiaries and supporting documents for material proceedings involving the Company. Further, we interacted with the relevant representatives of the Company to understand the status of various pending proceedings involving the Company. In relation to the litigation involving the Directors, relevant certificates have been received from the respective individuals, based on which appropriate disclosures, wherever applicable, have been included in the DRHP. With respect to consolidated disclosures on taxation proceedings involving the Company and the Subsidiaries, reliance has been placed on the lists provided by the Company and the certificate dated June 17, 2026 issued by the Independent Chartered Accountant.

5. **Material acquisition and divestments of the Company**

In accordance with Paragraph 10(D)(1)(c) of Part A of Schedule VI of the SEBI ICDR Regulations, all material acquisitions or divestments of business or undertakings, by the Company or its Subsidiaries in the last 10 years have been to be disclosed in the Offer Documents.

Further, public domain searches including on the websites of CIBIL and watchout investors for the Company, Directors, Key Managerial Personnel, Senior Management, Group Companies, Associates and the Subsidiaries were also carried out, and the results of such searches were analysed and written confirmations in respect of the relevant parties, were obtained.

For the purposes of disclosure of the professional experience and educational qualifications of Directors, Key Managerial Personnel and Senior Management, reliance was placed on relevant transcripts, degree certificates, form filings, officer orders, notifications, experience certificates, appointment letters issued by previous and current employers and other back-up documents in addition to certification received from the relevant Directors, Key Managerial Personnel and Senior Management.

7. *Statutory and/or Regulatory and Other Diligence*

The material agreements executed by, or in relation to, the Company and such other documents as have been deemed necessary and as have been provided to us by the Company, from time to time have been reviewed.

The description of the material approvals required for the business operations has been disclosed in the DRHP. We have appropriately disclosed details of such approvals in the section titled “*Government and Other Approvals*” of the DRHP.

In relation to the build-up of the existing share capital of the Company, the statutory form filings, board and shareholders’ resolutions, provided by the Company were reviewed. A certificate dated June 17, 2026, was also obtained from the PCS, confirming that the issuance of securities by the Company since incorporation have been made in compliance with the Companies Act, 2013.

The Company has received various correspondences on matters relating to operations of the Company, including inspections from SEBI which have been replied to by the Company. We have along with the Legal Counsels reviewed the inspection reports as a part of the diligence.

In connection with the identification of material subsidiaries under the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the “**SEBI Listing Regulations**”) and the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “**SEBI ICDR Regulations**”), NSE Clearing Limited has been identified as material pursuant to Para 9(L) of Schedule VI and Para 12(B)(2) of Schedule VI Part A of the SEBI ICDR Regulations and Regulation 16(1)(c) of SEBI Listing Regulations. NSE Investments Limited and NSE Clearing Limited are considered as the material subsidiaries only for the purpose of disclosure of audited financial statements on the website of the Company, in accordance with Para 11(I)(A)(ii) of Schedule VI Part A of the SEBI ICDR Regulations.

8. **Group Companies**

In accordance with the SEBI ICDR Regulations, the “Group Companies” have been considered to be (i) such companies (excluding the Subsidiaries) with which there were related party transactions, as covered under applicable accounting standards as disclosed in the Restated Consolidated Financial Information, and (ii) any other companies considered ‘material’ in accordance with the Materiality Policy. Certificates have been obtained from each of the Group Companies, the Governing Board of the Company, pursuant to its resolution have identified that except for one litigation involving NSDL which the Company considers material as disclosed under the section titled “*Outstanding Litigation and Material Developments – I. Litigation involving the Company – Litigation against the Company – Material Civil Litigation – 19.*” there are no pending litigation involving the Group Companies the adverse outcome of which may have a material impact on Company, along with certain other confirmations on the basis of which relevant disclosures have been made in the DRHP.

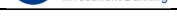
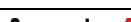
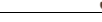
