Subject: Request for Withdrawal of Current DFRD and Submission of Fresh DFRD – SISTRY Foundation

Dear Sir/Madam,

We, **SISTRY Foundation**, would like to express our sincere gratitude to the NSE Social Stock Exchange Compliance Team for the valuable guidance, support and assistance extended to us throughout our SSE registration and fundraising process.

With reference to the **current DFRD submitted by SISTRY Foundation**, and pursuant to the guidance and observations received from the NSE SSE Compliance Team, we have carefully reviewed the structure and objectives contained in the existing DFRD.

We understand that the eligibility of SISTRY Foundation under the SSE framework, as supported by the CA-certified Annexure III submitted at the time of registration, is specifically based on the following two eligible social activities:

1. **Regulation 292E(2)(a)(iii)** – Promoting education, employability and livelihoods; and
2. **Regulation 292E(2)(a)(x)** – Promoting livelihoods for rural and urban poor, including enhancing the income of small and marginal farmers and workers in the non-farm sector.

The current DFRD, however, has been structured around five distinct thematic objectives. In view of the guidance received and to ensure complete consistency between our SSE registration, the proposed fundraising activities and the utilisation of proceeds, we believe that it would be appropriate and prudent to **withdraw the current DFRD** rather than undertake further clarification and reconciliation of the existing five-object structure.

Accordingly, we kindly request the **NSE SSE Compliance Team to permit the withdrawal of the current DFRD**, subject to the applicable NSE SSE procedure.

We further confirm that **SISTRY Foundation shall prepare and submit a Fresh DFRD strictly adhering to the guidance provided by the NSE SSE Compliance Team**. The Fresh DFRD will be structured specifically around the two eligible activities certified in Annexure III, and the proposed projects, activities and utilisation of proceeds will be directly mapped to the applicable provisions of **Regulation 292E(2)(a)(iii) and Regulation 292E(2)(a)(x)**.

We believe that this approach will ensure greater clarity, consistency and regulatory compliance throughout the fundraising process and will enable us to proceed with the proposed ZCZP fundraising on a clear and focused regulatory foundation.
