("Listing Regulations")

In terms of Regulation 30 of the Listing Regulations, we hereby inform that Shri Ankit Sharma has resigned as Chief Regulatory Officer - Listing & Investor Compliance and he stands relieved from his duties with effect from close of business hours today i.e., September 17, 2026. He will no longer be treated as a Key Management Personnel under the Securities Contracts (Regulation) (Stock Exchanges and Clearing Corporations) Regulations, 2018 ("SECC Regulations, 2018") from close of business hours today i.e. September 17, 2026. A copy of Shri Ankit Sharma's resignation email is enclosed herewith as Annexure A.

In view of the resignation of Shri Ankit Sharma, the NRC at its meeting held on September 11, 2026 approved the consolidation of both the functions under Regulatory department i.e., Member Compliance, Surveillance, Member Inspection & Investigation (presently under Shri Piyush Chourasia) and Listing and Investor Compliance (presently under Shri Ankit Sharma) into one. Consequently, Shri Piyush Chourasia shall be redesignated from "Chief Regulatory Officer - Member Compliance, Surveillance, Member Inspection & Investigation and Compliance Officer" to "Chief Regulatory Officer and Compliance Officer" of NSEIL under SECC Regulations, 2018 with effect from September 18, 2026.
