Important instructions for members:

- Kindly participate actively in the mock trading session to check the connectivity and to avoid login problems in live trading sessions from DR site.
- Members are requested to note that the Exchange Contingency Tests shall be carried out between 1.00 pm to 2.30 pm for mock trading on Saturday, July 07, 2018. Members are requested to plan their activities accordingly.
- Members having approved algorithmic software are required to adhere to circular 082/2013 (Download No. 24586) dated September 27, 2013 for mandatory participation in mock trading (contingency) session from DR site.
- For connecting to Primary/DR site, no changes in TAP settings are required. Settings of live session as of July 06, 2018 in TAP shall be retained to connect to all the above sessions of Primary/DR site.
- Members are requested to refer to Annexure- 3 for parameters to Login without TAP (Direct) and Annexure- 4 for Parameters for Login for Trade Drop Copy Facility.
- The Connect2NSE and Extranet facility will not be available for members (Timings are applicable to V-SAT/Leased Line/ Internet)
 - From 10 pm on Friday, July 06, 2018 to 07:00 am on Sunday, July 08, 2018
 - From 10 pm on Tuesday, July 10, 2018 to 08:00 am on Wednesday, July 11, 2018

- Co-location facility and Tick by Tick (TBT) feed shall be available. TBT feed will be available on the same Production IP's. There will not be any change in the IP's for accessing TBT feed for the mock.
- In Live trading session conducted from DR site, orders from colocation shall be routed from the main site to the BCP site. Similarly the dissemination shall be done from the BCP/DR site to the colocation racks in the main site
- Latencies experienced by Colo Participants will be different on Disaster Recovery/BCP day as compared to a normal trading day.
