CIR/MRD/DSA/18/2014 dated May 22, 2014 and in continuation of our circular no. 583/2012 dated July 05, 2012 regarding the eligibility criteria for placing companies exclusively listed on de-recognised/non-operational stock exchanges and features of dissemination board, UPSE has forwarded the list of exclusively listed companies with them for being placed on the Dissemination Board of NSE.
