The brief particulars of the scheme of reduction in capital are as mentioned below:

- a) The Scheme of Arrangement including Capital Reduction of the Company was approved by Hon'ble High Court of Judicature at Hyderabad vide order dated November 21, 2016.
- b) As per the scheme the paid-up share capital of the company is reduced from Rs. 12,79,80,000/- divided into 6,39,90,000 equity shares of Rs. 2/- each to Rs. 6,39,90,000/- divided into 3,19,95,000 equity shares of Rs. 2/- each.
- c) The company had fixed March 14, 2017 as record date for giving effect to the reduction of Share capital.
