Sub : Suspension of trading in Equity Shares for non-compliance with Regulation 33

Pursuant to the provisions of SEBI circular no. CIR/CFD/CMD/12/2015 dated November 30, 2015 with respect to Standard Operating Procedure (SOP) for suspension and revocation of trading of shares of listed entities for non-compliance of certain regulations of SEBI (LODR) Regulation, 2015; it is hereby informed that trading in below mentioned companies will be suspended w.e.f. September 08, 2017 on account of non-compliance with Financial results and non-payment of Fine for two consecutive quarters i.e. 31-Dec-2016 & 31-Mar-2017

The entire promoter shareholding of the companies shall be freezed w.e.f. August 17, 2017 till further notice.

In case, the aforesaid companies complies with respective requirement/s on or before September 04, 2017 (five days before the proposed date of suspension), the trading in Equity Shares of the said companies will not be suspended.

However, in case the companies fail to comply with the provisions of Financial Results and payment of Fine on or before September 04, 2017 then:

- Trading in the Equity Shares of the companies would be suspended w.e.f. September 08, 2017 and the suspension will continue till such time the Company complies.

- 15 days after suspension has been effected, trading in the shares of non-compliant companies would be allowed on Trade for Trade basis in (Series “BZ”) on the first trading day of every week for six months.
