Company Law Tribunal, Ahmedabad Bench vide its Order dated June 01, 2017.

- c) Effective date: July 04, 2017.
- d) Date of Allotment: August 14, 2017.
- e) Pursuant to the Composite scheme of arrangement between Aditya Birla Novo Limited (“Transferor Company”) and Grasim Industries Limited (“Demerged Company”) and Aditya Birla Capital Limited (“Resulting Company”) (earlier known as Aditya Birla Financial Services Limited) their respective shareholders and creditors. Aditya Birla Capital Limited will issue and allot to each shareholder of the Demerged Company, whose name is recorded in the register of members and records of the depository as members of the Demerged Company, on the Record Date 2, 7 (seven) equity shares of Rs 10 (Indian Rupees Ten) each of Resulting Company credited as fully paid up for every 5 (five) equity share of Rs 2 (Indian Rupees Two) each held by such shareholder in the Demerged Company (“Resulting Company New Equity Shares”).
