The brief particulars of the Composite Scheme of Arrangement and Amalgamation are as mentioned below:

- 1) The Hon'ble High Court of Gujarat, Ahmadabad vide its order dated December 16, 2016 has approved the Scheme of Arrangement & Amalgamation between Dishman Pharmaceuticals and Chemicals Limited ("Transferor Company/Amalgamated Company

1/Amalgamating Company 2”), Dishman Care limited (“Amalgamating Company 1”) and Carbogen Amcis (India) Limited (“Transferee Company/Amalgamated Company 2”) and their respective shareholders and creditors.

- b) Appointed Date: January 1, 2015.
- c) Effective date: March 17, 2017.
- d) Date of Allotment: June 06, 2017.
- e) Pursuant to scheme of Arrangement & Amalgamation, Dishman Care Limited, a wholly owned subsidiary of the Dishman Pharmaceuticals and Chemicals Limited was amalgamated with Dishman Pharmaceuticals and Chemicals Limited. Subsequently, pursuant to scheme Dishman Pharmaceuticals and Chemicals Limited got amalgamated with Carbogen Amcis (India) Limited. Further post amalgamation name of the Carbogen Amcis (India) Limited has been changed to “Dishman Carbogen Amcis Limited”. The consideration of the Scheme of Amalgamation was determined as follows:

Upon the Scheme coming into effect, the Dishman Carbogen Amcis Limited has issued and allotted 1 (One) fully paid up equity shares of Rs.2/- (Rupees Two only) each, for every 1 (One) fully paid-up equity shares of Rs. 2/- (Rupees Two only) each held by such shareholder in Dishman Pharmaceuticals and Chemicals Limited.
