- Scheme of Arrangement amongst (i) Gujarat Fluorochemicals Limited (“Demerged Company”) (ii) INOX Fluorochemicals Limited (“Resulting Company”) and their respective shareholders and creditors.
- Appointed Date: April 1, 2019
- Effective date: July 16, 2019
- Date of Allotment: August 08, 2019
- In terms of the Scheme and pursuant to Sections 230 to 232 and other applicable provision of the Companies Act 2013 and Section 2(19AA) of the Income-tax Act, 1961, the Chemical Business Undertaking along with all its assets, liabilities, contracts, arrangements, employees, Permits, licences, records, approvals, etc., without any further act, instrument or deed, be demerged from Demerged Company and transferred to and be vested in or be deemed to have been vested in the Resulting Company as a going concern.
