- a) The Hon'ble National Company Law Tribunal, Kolkata Bench vide its order dated November 08, 2019 has approved the scheme of Arrangement between Kesoram Industries Limited ("Demerged Company") and Birla Tyres Limited ("Resulting Company") and their respective shareholders.
- b) Appointed Date: January 01, 2019

- c) Effective date: December 04, 2019
- d) Date of Allotment: December 27, 2019
- e) In terms of the Scheme and pursuant to Sections 230 to 232 read with Section 66 of the Companies Act 2013 and Section 2(19AA) of the Income-tax Act, 1961, the Securities Business Undertaking along with all its assets, liabilities, contracts, arrangements, employees, Permits, licenses, records, approvals, etc. shall, without any further act, instrument or deed be demerged from Demerged Company has been transferred and vested in the Resulting Company as a going concern.
- f) In consideration of the above demerger the Resulting company (“Birla Tyres Limited”) has issued & allotted “1 (one) equity share of Rs. 10 (Rupees Ten each) of Resulting Company, credited as fully paid up for every equity share of Rs. 10 (Rupees Ten each) each held by such shareholder in Demerged Company of the (“Kesoram Industries Limited”).
