The brief particulars of the Scheme of Arrangement are as mentioned below:

- a) The Hon'ble National Company Law Tribunal, Delhi Bench vide its order dated February 20, 2020 has approved the Scheme of Arrangement between Sharda Motor Industries Limited and NDR Auto Components Limited and their respective shareholders and creditors.
- b) Appointed Date: December 31, 2018
- c) Effective date: March 16, 2020
- d) Date of Allotment: March 30, 2020
- e) The National Company Law Tribunal, New Delhi Bench vide its order dated February 20, 2020 has approved the Scheme of Arrangement between Sharda Motor Industries Limited and NDR Auto Components Limited and their respective shareholders.

In terms of the Scheme and pursuant to Sections 230 to 232 read with Section 66 of the Companies Act 2013 and Section 2(19AA) of the Income-tax Act, 1961, the Automobile Seating Undertaking along with all its assets, liabilities, contracts, arrangements, employees, Permits, licenses, records, approvals, etc. has been transferred and vested in NDR Auto Components Limited as a going concern.

In consideration of the above demerger, the NDR Auto Components Limited has issued and allotted “1 (one) Equity Shares having a face value of INR 10/- (Indian Rupees Ten) each fully paid up of the NDR Auto Components Limited for every 1 (one) Equity Shares having a face value of INR 10/- (Indian Rupees Ten) each fully paid up of the Sharda Motor Industries Limited.
