Sub: Shifting of securities to Z category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (“SOP Circular”), Members of the Exchange are hereby informed that the below mentioned Company have been identified as non-compliant with Regulation 33 (i.e., Submission of Financial Result) of SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters’ i.e., September 30, 2021 and December 31, 2021 at other Stock Exchange.
