Sub: Shifting of Securities to Z category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020, Members of the Exchange are hereby informed that the below mentioned Company has been identified as Non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") for two consecutive quarters' i.e., December 31, 2021, and March 31, 2022. Details are as under: -

*The trading in securities will be shifted to Z category however, since the Company is already suspended for non-payment of ALF vide NSE Circular No. NSE/CML/50068 dated October 22, 2021, the trading will be permitted once in a week.

Therefore, trading in securities of the above-mentioned Company shall be transferred to 'Z' Category with effect from June 27, 2022, if the Company do not comply with the Regulation 31 of the Listing Regulations as per the provisions of SOP Circular on or before June 22, 2022.

The below mentioned Companies have also been identified as non-compliant Companies under Regulation 31 (i.e., Submission of Shareholding Pattern) of the Listing Regulations for two consecutive quarters' i.e., December 31, 2021, and March 31, 2022. Hence, the securities of these Companies are eligible to be transferred to Z category.
