Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020, Members of the Exchange are hereby informed that the below mentioned companies have been identified as non-compliant with Regulation 76 (i.e., Submission of Reconciliation of Share Capital Audit Report) of SEBI (Depositories and Participants) Regulations, 2018 (“Depositories Regulations”) for two consecutive quarters’ i.e., March 31, 2022 and June 30, 2022. Details are as under: -

Therefore, trading in securities of the above-mentioned company shall be transferred to ‘Z’ Category with effect from October 03, 2022, if the company do not comply with corresponding regulations as per the provisions of SOP Circular on or before September 28, 2022 and trading shall be permitted once in a week only on account of non-payment of Annual Listing Fees vide NSE Circular No. NSE/CML/47401 dated February 19, 2021.

The below mentioned Companies have also been identified as non-compliant companies under Regulation 76 (i.e. Submission of Reconciliation of Share Capital Audit Report) of the Depositories Regulations for two consecutive quarters’ i.e. March 31, 2022 and June 30, 2022.

The trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (‘Z’ Series) with effect from October 03, 2022, for the said non-compliance. However, securities of these companies are already trading in ‘Z’ Category pursuant to various Exchange Circulars, hence no separate action will be taken. Details are as under: -
