Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (“SOP Circular”), Members of the Exchange are hereby informed that Parenteral Drugs (India) Limited have been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (‘Listing Regulations’) for two consecutive quarters’ i.e., June 30, 2022 and September 30, 2022. Details are as under: -

Therefore, trading in securities of Parenteral Drugs (India) Limited shall be transferred to ‘Z’ (“BZ Series”) category with effect from December 26, 2022, if the company do not comply with Regulation 31 of the Listing Regulations as per the provisions of SOP Circular on or before December 21, 2022.

The below mentioned companies have also been identified as non-compliant companies under Regulation 31 (i.e., Submission of Shareholding Pattern) of the Listing Regulations for two consecutive quarters’ i.e., September 30 and June 30, 2022. Hence the trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (“BZ” Series) with effect from December 26, 2022, for the said non-compliance. However, securities of these companies are already trading in ‘Z’ Category pursuant to various Exchange Circulars, details of which are as under: -
