Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (“SOP Circular”), Members of the Exchange are hereby informed that the below mentioned companies have been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (LODR) Regulations, 2015 for two consecutive quarters’ i.e. September 30, 2022 and December 31, 2022. Details are as under: -

Therefore, trading in securities of the above-mentioned companies shall be transferred to ‘Z’ (“BZ Series”) Category with effect from March 27, 2023, if these companies do not comply with Regulation 31 of the SEBI (LODR) Regulations, 2015 as per the provisions of SOP Circular on or before March 22, 2023.

The below mentioned Companies have also been identified as non-compliant companies under Regulation 31 i.e., (Submission of Shareholding Pattern) of SEBI (LODR) Regulations, 2015 for two consecutive quarters’ i.e. September 30, 2022 and December 31, 2022.

Hence the trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (“BZ” Series) with effect from March 27, 2023, for the said non-compliance.
