Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (“SOP Circular”), Members of the Exchange are hereby informed that the below mentioned company has been identified as non-compliant with Regulation 76 (i.e., Submission of Reconciliation of Share Capital Audit Report) of SEBI (Depository and Participants) Regulations, 2018 for two consecutive quarters’ i.e. September 30, 2022 and December 31, 2022. Details are as under: -

Therefore, trading in securities of the above-mentioned companies shall be transferred to ‘Z’ Series (“BZ”) with effect from April 03, 2023, if above mentioned company do not comply with Regulation 76 of the SEBI (Depository and Participants) Regulations, 2018 as per the provisions of SOP Circular on or before March 28, 2023.

Hence the trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (“BZ”/“SZ” Series) with effect from April 03, 2023, for the said non-compliance.
