Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020 (“SOP Circular”), Members of the Exchange are hereby informed that the below mentioned company have been identified as non-compliant with Regulation 76 (i.e., Submission of Reconciliation of Share Capital Audit Report) of SEBI (Depository and Participants) Regulations, 2018 for two consecutive quarters’ i.e., December 31, 2022 and March 31, 2023.
