Sub: Shifting of securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 (“Master Circular”) (Erstwhile SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020), Members of the Exchange are hereby informed that the below mentioned companies have been identified as non-compliant with Regulation 33 (i.e., Submission of Financial Results) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters’ i.e., March 31, 2023 and June 30, 2023. Details are as under: -

Therefore, trading in securities of the above-mentioned companies will be transferred to ‘Z’ (“BZ Series”) with effect from October 30, 2023, if the above-mentioned companies do not comply with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as per the provisions of Master Circular on or before October 25, 2023.

The below mentioned companies have also been identified as non-compliant companies under Regulation 33 i.e., (Submission of Financial Results) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for two consecutive quarters’ i.e., March 31, 2023, and June 30, 2023. Hence the trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (“BZ” Series) with effect from October 30, 2023, for the said non-compliance.
