However, he became a Promoter of our Company in his capacity as the Chairman and Managing Director of the Company, and on account of possessing the ability to control management or policy decisions by virtue of his position and responsible for directing the day-to-day operations and decision making of the Company since 1998. Further, he holds more than 90% of the direct/ indirect shareholding of two of our Corporate Promoters, namely Saraf Hotels and Juniper Investments, which collectively own 50% of the shareholding of our Company and he also holds directorships on the boards of directors of each of these companies.
