Sub: Shifting of securities to "Z" Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 ("Master Circular") (Erstwhile SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/12 dated January 22, 2020), Members of the Exchange are hereby informed that the below mentioned Company has been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") for two consecutive quarters i.e., September 30, 2023 and December 31, 2023. Details are as under:-

Hence, the trading in securities of these companies is also eligible to be transferred to 'Z' Category ("BZ" Series) with effect from March 26, 2024, for the said non-compliance.
