The brief particulars of the Scheme of Arrangement are as mentioned below:

- The Hon'ble National Company Law Tribunal, Hyderabad Bench, vide its order dated August 17, 2023 has approved the Scheme of Arrangement between DRS Dilip Roadlines Limited ("Demerged Company") and DRS Cargo Movers Limited ("Resulting Company") and their respective shareholders and creditors.

For the transfer and vesting of the warehouses division of DRS Cargo Movers Private Limited, DRS Dilip Roadlines Limited issued and allotted Equity Shares to the shareholders of DRS Cargo Movers Limited in the following proportion:

1 (one) Equity Share of face value of Rs.10/- (Rupees Ten only) each fully paid up of the DRS Cargo Movers Limited shall be issued and allotted by the DRS Cargo Movers Limited for every 2(two) fully paid-up equity shares of the face value of Rs.10/- (Rupees Ten only) each held in the DRS Dilip Roadlines Limited.

Prior to the Scheme, the paid-up Equity Capital of DRS Dilip Roadlines Limited was Rs. 15,06,24,030/- consisting of 1,50,62,403 equity shares of Face Value of Rs.10/- each.
