Subject: Restriction in trading of securities in Trade for Trade category pursuant to non-compliance with Regulation 14 of SEBI LODR 2015 for the Financial Year ended 2023-24.

In continuation to the Exchange Circular dated April 25, 2024, (Exchange Circular **Reference No. NSE/CML/61734**) (“erstwhile Exchange Circular”). The revised details to the Annexure I, II & IV of above mentioned erstwhile Circular are as enclosed herewith.

All other particulars and details mentioned in the erstwhile Exchange Circular shall remain unchanged. The revised Exchange Circular shall be read in conjunction with the Circular dated April 25, 2024.

Pursuant to the provisions of aforesaid Exchange Circular, members are requested to note that the list of securities mentioned in **Annexure I** are observed to be non-compliant at the Exchange and are continued to be trading in Trade for Trade category (BE/BZ). However, pursuant to non-compliance with regards to non-payment of outstanding ALF, the securities of the Companies shall be available for trading only on the first trading day of every week in Trade for Trade category (BE/BZ).
