### Sub: Shifting of trading in securities to “Z” Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 (“Master Circular”), Members of the Exchange are hereby informed that the below mentioned Company has been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding pattern) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters i.e. December 31, 2023 and March 31, 2024. Details are as under: -

Therefore, trading in securities of the above-mentioned Company shall be transferred to ‘Z’ (“BZ Series”) Category with effect from June 24, 2024, if this company does not comply and pay the fine for Regulation 31 of the SEBI (LODR) Regulations, 2015 as per the provisions of Master Circular on or before June 19, 2024.

The below mentioned Companies have also been identified as non-compliant under Regulation 31 i.e., (Submission of Shareholding Pattern) of Listing Regulations for two consecutive quarters i.e. December 31, 2023 and March 31, 2024.

Hence, the trading in securities of these Companies is also eligible to be transferred to ‘Z’ Category (“BZ” Series) with effect from June 24, 2024, for the said non-compliance.
