The brief particulars of the Scheme of Arrangement are as mentioned below:

- a) The National Company Law Tribunal, Mumbai Bench, vide its order dated May 07, 2024 has approved the Scheme of Arrangement among Sanofi India Limited (“Demerged Company” or “SIL”) and Sanofi Consumer Healthcare India Limited (“Resulting Company” or “SCHIL”) and their respective shareholders and creditors.

Demerger of ‘Consumer Healthcare Business’ (Demerged Undertaking) of Sanofi India Limited (SIL) and vesting the same into Sanofi Consumer Healthcare India Limited (SCHIL), whereby upon coming into effect of the scheme and in consideration of;

“1 (One) Fully Paid-up Equity Share of Rs.10/- each of Sanofi Consumer Healthcare India Limited for every 1 (One) Fully Paid-Up Equity Share of Rs.10/- each held in Sanofi India Limited”

Prior to the Scheme, the paid-up Equity Capital of Sanofi Consumer Healthcare India Limited was Rs. 2,00,00,000/- consisting of 20,00,000 equity shares of Face Value of Rs.10/- each which are cancelled.

The issued, subscribed and paid-up equity capital of Sanofi Consumer Healthcare India Limited, post Arrangement is Rs. 23,03,06,220/- consisting of 2,30,30,622 equity shares of face Value of Rs. 10/- each fully paid.
