Sub: Shifting of trading in Securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 (“Master Circular”) (Erstwhile SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023), Members of the Exchange are hereby informed that the below mentioned Companies have been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters. Details are as under:-

Therefore, trading in securities of the above-mentioned companies shall be transferred to ‘Z’ Category (“BZ/SZ Series”) with effect from December 27, 2024, if the company does not comply with Regulation 31 of the Listing Regulations as per the provisions of Master Circular on or before December 23, 2024.

The below mentioned Companies have also been identified as non-compliant under Regulation 31 i.e., (Submission of Shareholding Pattern) of Listing Regulations for two consecutive quarters i.e. June 30, 2024 and September 30, 2024.

Hence, the trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (“BZ” Series) with effect from December 27, 2024, for the said non-compliance.
