### Sub: Shifting of trading in Securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 (“Master Circular”), Members of the Exchange are hereby informed that below mentioned Companies have been identified as non-compliant with Regulation 33 (i.e., Submission of Financial Results) of SEBI (LODR) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters i.e. June 30, 2024 and September 30, 2024. Details are as under: -

Therefore, trading in securities of the above-mentioned companies shall be transferred to ‘Z’ (“BZ Series”) Category with effect from January 24, 2025, if these companies do not comply with Regulation 33 of Listing Regulations as per the provisions of Master Circular on or before January 21, 2025.

The below mentioned Companies have also been identified as non-compliant under Regulation 33 i.e., (Submission of Financial Results) of Listing Regulations for two consecutive quarters i.e. June 30, 2024 and September 30, 2024.

Hence, the trading in securities of these companies is also eligible to be transferred to ‘Z’ Category (“BZ/SZ” Series) with effect from January 24, 2025, for the said non-compliance.
