Sub: Continuation of trading in Securities in Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 (“Master Circular”) (Erstwhile SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023), Members of the Exchange are hereby informed that the below mentioned Companies have been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding pattern) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters i.e., December 31, 2024 and March 31, 2025.

Therefore, the trading in securities of these companies is eligible to be transferred to ‘Z’ Category (“BZ/SZ” Series) with effect from June 23, 2025, for the said non-compliance.
