Sub: Shifting of trading in Securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 ("Master Circular"), Members of the Exchange are hereby informed that the below mentioned Companies have been identified as non-compliant with Regulation 33 (i.e., Submission of Financial Results) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") for two consecutive quarters i.e., March 31, 2025 and June 30, 2025. Details are as under: -

Therefore, trading in securities of the above-mentioned Companies will be transferred to 'Z' Series ("BZ") with effect from October 27, 2025, if the Companies do not comply with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as per the provisions of Master Circular on or before October 20, 2025.

The below-mentioned Companies have also been identified as non-compliant Companies under Regulation 33 i.e., (Submission of Financial Results) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for two consecutive quarters i.e. March 31, 2025 and June 30, 2025.

Hence, the trading in securities of these Companies are also eligible to be transferred to 'Z' Category ("BZ/SZ" Series) with effect from October 27, 2025, for the said non-compliance. However, securities of these Companies are already trading in 'Z' Category pursuant to various Exchange Circulars, details of which are as under: -
