Sub: Shifting of trading in Securities to Z Category

Pursuant to SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 (“Master Circular”) (Erstwhile SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023), Members of the Exchange are hereby informed that the below mentioned Companies have been identified as non-compliant with Regulation 76 (i.e., Submission of Reconciliation of share capital audit report) of SEBI (Depositories and Participants) Regulations, 2018 (“Depository Regulations”) for two consecutive quarters i.e., June 30, 2025 and September 30, 2025. Details are as under: -

Therefore, trading in securities of the above-mentioned Companies will be transferred to ‘Z’ Series (“BZ”) with effect from January 02, 2026, if the Companies do not comply with Regulation 76 of the Depository Regulations as per the provisions of Master Circular on or before December 30, 2025.

The below-mentioned Companies have also been identified as non-compliant Companies under Regulation 76 i.e., (Submission of Reconciliation of share capital audit report) of Depository Regulations for two consecutive quarters i.e. June 30, 2025 and September 30, 2025.

Therefore, the trading in securities of the below-mentioned Companies are eligible to be transferred to ‘Z’ Category (“BZ/SZ” Series) with effect from January 02, 2026, for the said non-compliance. However, securities of these Companies are already trading in ‘Z’ Category pursuant to various Exchange Circulars, details of which are as under: -
