The brief particulars of the Scheme of Arrangement are as mentioned below:

- a) The National Company Law Tribunal, Mumbai Bench, Court V, vide its order dated December 16, 2025 has approved the Scheme of Arrangement between Vedanta Limited (“Demerged Company”) and Vedanta Aluminium Metal Limited (“Resulting Company 1”), Vedanta Power Limited (formerly known as Talwandi Sabo Power Limited) (“Resulting Company 2”), Vedanta Oil & Gas Limited (formerly known as MALCO Energy Limited) (“Resulting Company 3”) and Vedanta Iron and Steel Limited (“Resulting Company 4”) and their respective shareholders under sections 230 to 232 and other applicable provisions of the Companies Act, 2013.

The scheme of arrangement inter alia provides for:

Demerger of the Oil and Gas Undertaking (Demerged Undertaking) of Vedanta Limited (VEDL) and vesting the same into Vedanta Oil and Gas Limited (formerly known as MALCO Energy Limited) (VOGL), an unlisted wholly owned subsidiary (WOS) of VEDL.

“01 (One) Fully Paid-Up Equity Share of the Face Value of Re. 1/- each of Vedanta Oil and Gas Limited (formerly known as MALCO Energy Limited) for every 01 (One) Fully Paid-Up Equity Share of the Face Value of Re. 1/- each held by such members in Vedanta Limited”

Prior to the Scheme, the paid-up equity capital of Vedanta Oil and Gas Limited (formerly known as MALCO Energy Limited) was Rs. 4,67,32,812/- (Rupees Four Crores Sixty-Seven Lakhs Thirty-Two Thousand Eight Hundred Twelve Only) consisting of 2,33,66,406 equity shares of Face Value of Rs. 2/- each and the same was cancelled pursuant to Scheme of Demerger.

The issued, subscribed and paid-up equity capital of Vedanta Oil and Gas Limited (formerly known as MALCO Energy Limited), post Arrangement is Rs. 3,91,03,88,057/- (Rupees Three Hundred Ninety-One Crore Three Lakhs Eighty-Eight Thousand Fifty-Seven Only) consisting of 3,91,03,88,057 equity shares of face Value of Re. 1/- each fully paid.
