Sub: Continuation of trading in Securities in Z Category

Pursuant to SEBI Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 issued on July 11, 2023 and last updated on January 30, 2026 (hereinafter referred to as "Master Circular"), Members of the Exchange are hereby informed that the below-mentioned Companies have been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015 for two consecutive quarters i.e., December 31, 2025 and March 31, 2026.
