Sub: Shifting of trading in Securities to Z Category

Pursuant to SEBI Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 (“Master Circular”) issued on July 11, 2023 and last updated on January 30, 2026, Members of the Exchange are hereby informed that the below-mentioned Company has been identified as non-compliant with Regulation 33 i.e., (i.e., Submission of Financial Results) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) for two consecutive quarters i.e., December 31, 2025 and March 31, 2026. Details are as under: -

Therefore, trading in securities of the above-mentioned Company will be transferred to ‘Z’ Series (“BZ”) with effect from August 10, 2026, if the Company does not comply with Regulation 33 of the Listing Regulations as per the provisions of Master Circular on or before August 05, 2026.

The below-mentioned Companies have also been identified as non-compliant Companies under Regulation 33 (i.e., Submission of Financial Results) of Listing Regulations for two consecutive quarters i.e., December 31, 2025 & March 31, 2026 (For SME Companies- September 30, 2025 & March 31, 2026).

Therefore, the trading in securities of these Companies is eligible to be transferred to ‘Z’ Category (“BZ/SZ” Series) with effect from August 10, 2026, for the said non-compliance.
