Sub: Continuation of trading in Securities in Z Category

Pursuant to SEBI Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 ("Master Circular") issued on July 11, 2023 and last updated on January 30, 2026 (hereinafter referred to as "Master Circular"), Members of the Exchange are hereby informed that the below-mentioned Companies have been identified as non-compliant with Regulation 31 (i.e., Submission of Shareholding Pattern) of SEBI (Listing obligations and Disclosure Requirements) Regulations, 2015 for two consecutive quarters i.e., March 31, 2026 and June 30, 2026.

Therefore, the trading in securities of the below-mentioned Companies is eligible to be transferred to 'Z' Category ("BZ/SZ" Series) with effect from September 28, 2026, for the said non-compliance.
