Sub: Shifting of trading in Securities to Z Category

Pursuant to SEBI Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 (“Master Circular”) issued on July 11, 2023 and last updated on January 30, 2026, Members of the Exchange are hereby informed that the below-mentioned Company has been identified as non-compliant with Regulation 76 i.e., (Submission of Reconciliation of Share Capital Audit Report) of SEBI (Depositories and Participants) Regulations, 2018 (“Depository Regulations”) for two consecutive quarters i.e. March 31, 2026 and June 30, 2026.
