Sub: Mock in the Cash Market Segment for interoperability among Clearing Corporations

Pursuant to the mock trading circulars issued by exchanges for the mock trading to be conducted on June 22, 2019 in cash market segment; NSE Clearing Limited will conduct mock operations and provide reports, carry out clearing processes etc. in respect of the trades executed during the mock trading session. The files/reports downloaded as part of these mock operations are strictly for testing purpose only and will not result in any actual obligation in terms of funds/securities pay-in and/or pay-out.

All the members/custodial participants of custodians where NSE Clearing Limited has been designated as clearing corporation in the cash market segment will be mapped to NSE Clearing Limited in all Exchanges for the purpose of this mock session only. The activities under mock operations scope as outlined in subsequent sections will be applicable on the mock on June 22, 2019 only.

Mock Operations Scope

The clearing operations carried out on T-day (trade date) and T+1 day (next working day after trade date) will be carried out as part of the mock clearing operations. The details of the dates and settlement type/number to be used in the mock operations shall be as under:
