Members shall be able to login to live trading system from June 05, 2017 onwards with the following software's only –

- NEAT CM 9.31.0
- NEAT+ 7.2.3

Further, as per Exchange circular NSE/CMTR/34761 dated April 28, 2017, login with the older version i.e. NEAT 9.30.0 & NEAT+ 7.2.2 shall be discontinued w.e.f. June 03, 2017.

3. Kindly participate actively in the mock trading session from all trading software and re-login into live environment to check the connectivity and to avoid login problems on Monday, June 05, 2017.
