NIFTY100 Low Volatility 30 Index aims to measure the performance of the low volatile securities in the large market capitalisation segment.

The securities are selected from NIFTY 100 index and should be available for trading in derivative segment(F&O).The selection of securities and its weights in NIFTY100 Low Volatility 30 are based on volatility. Volatility of the securities is calculated as the standard deviation of daily price returns (log normal) for last one year.

In order to make the index replicable for passive products, weightage of the stocks with turnover less than the stock having the lowest turnover in NIFTY 50, has been capped at 3%.

Index Methodology

Eligible Universe:

- The securities forming part of NIFTY 100 are eligible for inclusion in the index
- Securities should have a minimum listing history of 1 year
- Securities should be available for trading in derivative segment (F&O).
- DVR shares are not eligible for inclusion in the index

Selection Criteria:

- Stocks are assessed on the basis of volatility for index inclusion
- Volatility is calculated as the standard deviation of daily price returns (log normal) for last one year
- Eligible stocks are then ranked based on their volatility score, with stock having lowest volatility getting a rank of 1
- Top 30 ranked stocks with least volatility form part of the index

Index Rebalancing:

- The index is reviewed on quarterly basis
- At time of review, if the existing constituent of the index is ranked within top 60 based on the low volatility score, then the stock is retained in the index
- Stocks based on lowest volatility rank gets included in the index, depending on the number of exclusions from the index due to above rule

Index Governance:

A professional team at IISL manages the NIFTY indices. There is a three-tier governance structure comprising the board of directors of IISL, the Index Policy Committee, and the Index Maintenance Sub-committee.
