Liquidity Enhancement Scheme – Gold Mini Options

This has reference to Exchange circular nos. NSE/COM/44457 dated May 22, 2020; NSE/COM/44655 dated June 15, 2020, NSE/COM/45680 dated September 11, 2020, NSE/COM/46436 dated November 24, 2020, NSE/COM/48295 dated May 18, 2021, NSE/COM/48692 dated June 21, 2021, and NSE/COM/50357 dated November 22, 2021.

The LES scheme for Gold Mini Options (including the LES on additional strikes) shall be extended for 6 months and shall be in operation till 7th December 2022.
