Sub: Storges charges for Base Metal and Bullion in Commodity Derivatives Segment

Members are requested to take note of following storage charges for Base Metal and Bullion:

Commodity	Deposit Date	Applicable Storage charges
Aluminum, Aluminum Mini, Lead, Lead Mini, Nickel, Zinc, Zinc Mini and Copper	1 st to 15 th of month	Rs.30/MT/Day
	16 th to 25 th of month	Rs.35/MT/Day
	26 th to 30 th /31 st of month	Rs.40/MT/Day
	Subsequent month onwards	Rs.35/MT/Day

Additionally, handling charges (unloading or loading) in case of use of Forklift - Rs 190 Per MT and in case of use of Forklift & Hydera - Rs 265 Per MT - shall be directly payable to WSP.

Commodity	Unit	Applicable Storage Charges
Gold	1 Kg	Rs. 12 Per 1kg bar per day
Gold Mini	100 Gm	Rs. 2 Per 100gm bar per day
Gold Guinea	8 Gm	Rs. 0.25 Per 8gm coin /bar per day
Gold 1Gm	1 Gm	Rs. 0.25 Per 1gm coin /bar per day
Silver Micro	1 Kg	Rs. 0.75 Per 1kg per day
Silver Mini	5 Kg	Rs. 3.75 Per 5kg per day
Silver	30 Kg	Rs. 22.50 Per 30Kg per day

Additionally, following charges shall be directly payable to the vault: -

1. Transaction Charges per Deposit: Rs 350 per transaction
2. Charges for Window Delivery: Rs.350 per transaction

3. Freight Charges for IN CITY Delivery (within a radius of 25 kms) i.e. Door Delivery:
 - **Gold:** Rs 10 / kg with a minimum charge of Rs 1500, Rs 30 per kg additional for over and above 10 kg.
 - **Silver:** Rs 2500/- per delivery up to 800kg Rs. 5 per additional charge per kg over and above 800 kg
4. Loading unloading charges Rs 35 per bar/per activity will be applicable for Silver window as well door delivery if any.
5. GST and any type of govt levy (Duty /Tax) as applicable would be charged in above Billing.
