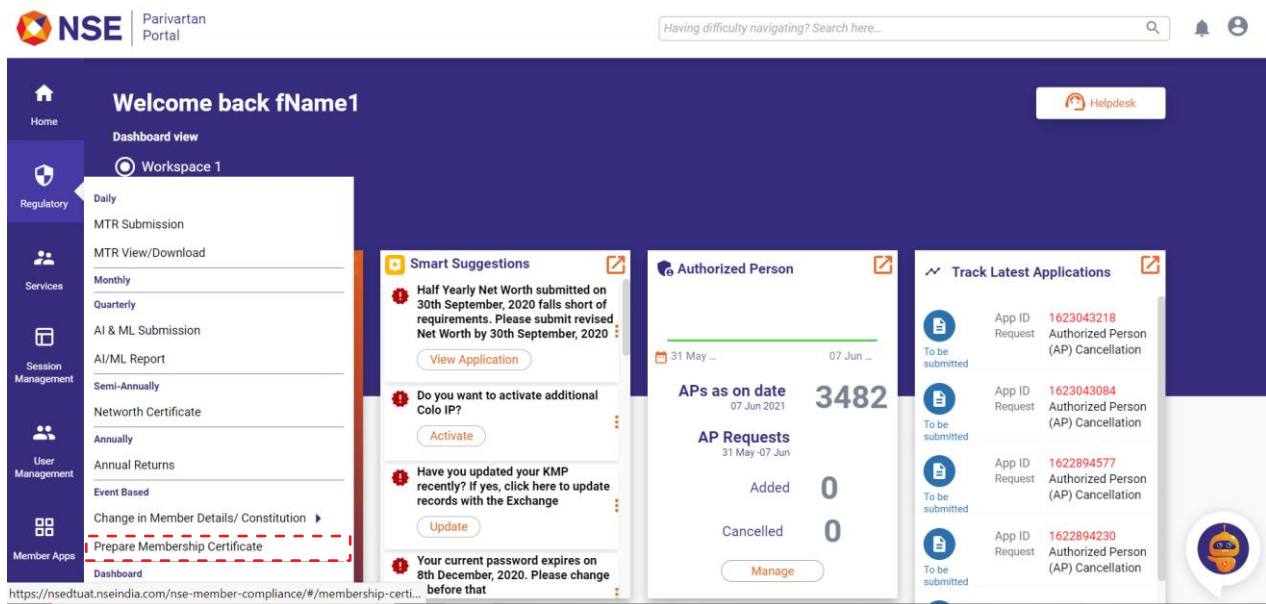

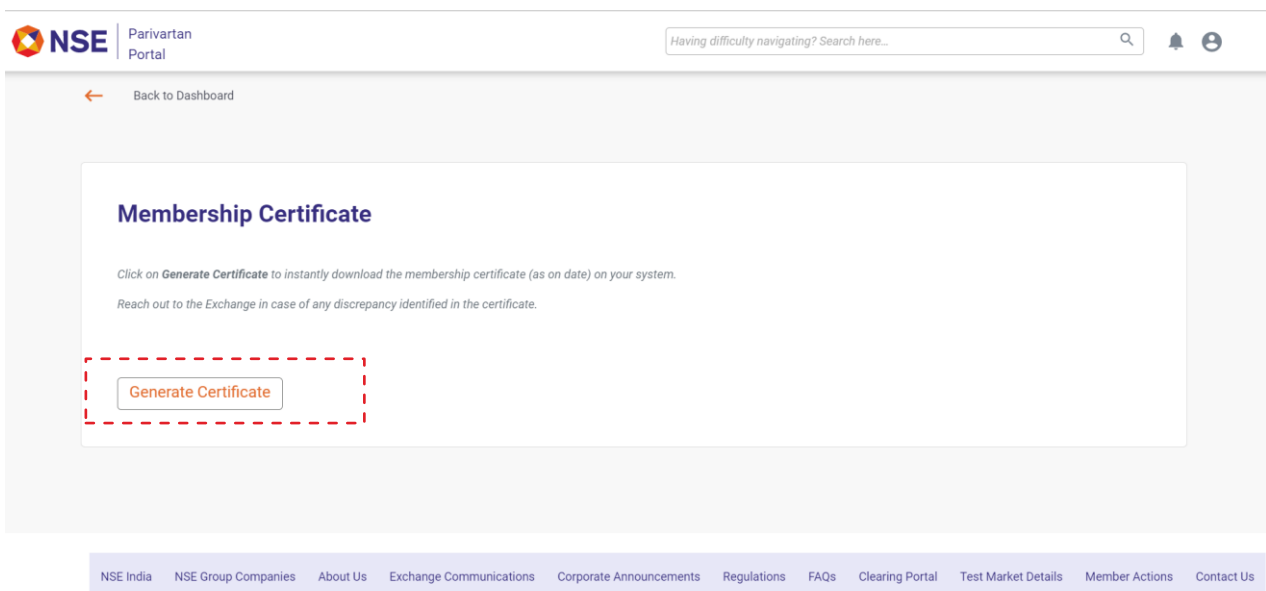
1. Generate Membership Certificate
