Mock Trading from BCP/DR Site on Saturday, April 22, 2017

Exchange shall be conducting a mock trading session on Saturday, April 22, 2017 from Primary and BCP site. The mock will be followed by a Re-Login session from Primary site in order to avoid log in problems on Monday, April 24, 2017. The schedule of the mock trading is as follows:

Trade modification end time	15:40 hrs.

Re-Log in Session:

Saturday, April 22, 2017	Time
Live Re-login start time	17:00 hrs.
Live Re-login close time	17:30 hrs.

Members are required to perform the following:

- **For connecting to Primary/DR site, no change in TAP settings is required. Settings of live session as of Friday, April 21, 2017 in TAP shall be retained to connect to all the above sessions of Primary/DR site.**
- All the outstanding orders shall be purged before the start of trading from BCP site. Members using NNF software should clear the outstanding orders of session 1 in their systems before trading from BCP site.
- Members should note that for Multicast TBT feed, sequence number will start from '1' once trading starts from BCP site.
