Important instructions regarding mock trading session

1. Refer to Exchange consolidated circular download ref no NSE/MSD/45703 dated September 15, 2020 for Interactive Connectivity Parameters.
2. Installation procedure for NEAT+ is available on extranet path /common/Installation_Procedure.
3. Members are requested to refer to circular reference no. NSE/MSD/46441 regarding Testing of software used in or related to Trading and Risk Management. Members may choose to participate either in Mock Trading Session or Simulated environment for fulfilling their regulatory requirements in accordance to SEBI circular no. SEBI/HO/MRD1/DSAP/CIR/P/2020/234 dated November 24, 2020.
4. Trades resulting from this session shall not attract any obligation in terms of funds pay-in and/or pay-out.
5. Kindly participate actively in the mock trading session from all trading software and re-login into live environment to check the connectivity and to avoid login problems on Monday, August 30, 2021.

Annexure – 2

Pre-requisites / General guidelines for participating in the Mock environment

All members eligible to trade in FO segment in live market are enabled for participating in the mock trading sessions with their existing user ids, IP and Box Id mapping that of the live environment. Accordingly, members are requested to ensure the following:

1. You are able to successfully telnet the Exchange host from the IP you wish to participate
2. The Box ID with appropriate messages has been created on the IP in the respective segments you wish to participate.
3. In case you wish to participate via Non-NEAT frontend (NNF) applications, kindly ensure that the User Id is of type dealer, is converted for NNF and is mapped with the IP.
4. Members are required to set appropriate branch and / user limits from their corporate manager terminal in the respective segments, prior to placing orders in the Mock.
5. Members are requested to send requests via email pertaining to following activities with the details of User ID and segment for Exchange action only for the purpose of MOCK participation.
 - a. Pro enablement
 - b. CTCL conversion
 - c. Password Reset for Corporate Manager user id
- d. Unlocking of Corporate Manager user id.
6. Password Reset / Unlocking of all other types of user ids should be done from the corporate manger user id by the member in the respective segments.

Annexure 3

Additional Features

Order Price Alert in NEAT+ : Alerts at the time of order entry in Option Contracts.

In continuation to Exchange circular reference no: NSE/FAOP/49118 dated July 31, 2021 regarding Pre-Trade risk controls, Members are requested to note that below changes shall be made available at the time of order entry in option contract in new version of NEAT+ 7.4.7 (onwards) in addition to alerts provided at the time of order entry in future contracts.

If the user places limit order at price which is away from prevailing market prices, a warning alert "Order price is significantly away from reference price << >>. Please exercise caution. Do you still want to continue with the order price?" will be generated on Front End (FE) for re-confirmation of the order price from the dealer.

- For Buy Normal orders: - Whenever limit order price is greater than or equal to X above the LTP ie $LTP + X$ (or $LTP + X\%$ of LTP), order price alert will be generated.
- For Sell Normal orders: - Whenever limit order price is lesser than or equal to X below the LTP ie $LTP - X$ (or $LTP - X\%$ of LTP), order price alert will be generated.
- X shall be set as follows:
 - X shall be 20 if LTP is ≤ 50 ,
 - X shall be 40% if LTP is > 50
- Exchange may review and change the 'X' value in future, if required.
- By default, cursor will be set on 'No' option, so that if 'Enter' tab is pressed by the user, order entry will get rejected and Cursor will be re-set at order price in the order entry window.
- If option 'Yes' is selected, order will be accepted and sent to host.
- Members are requested to set the contract on Market Watch area before placing the order in it, to get the Order price alert based on the LTP as per aforesaid functionality.
- If LTP is not available for the day i.e. contract is not traded for the day, Base price of the contract shall be referred for comparison.
- Please note that the functionality / calculations are based on the available Last Trade Price via broadcast / base price for the contract in the NEAT+ FE. Above functionality shall be applicable for all limit orders on Options contracts, of following types:
 - Normal/Offline
 - 2L and 3L
 - Closeout
- Above functionality shall not be applicable for Market and Stop loss orders.
