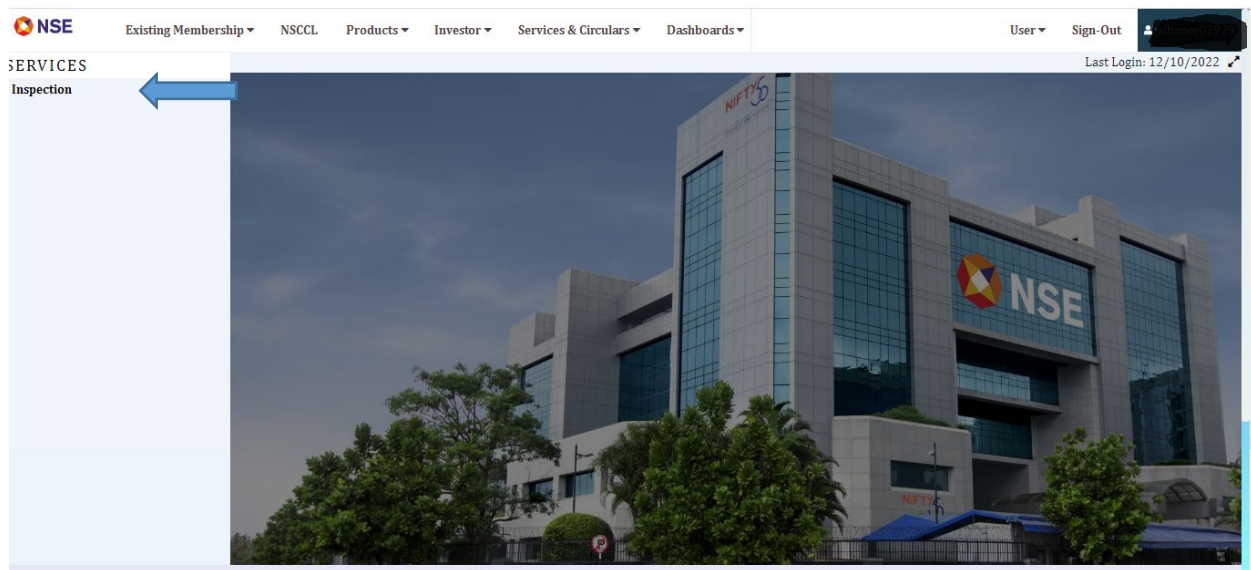
MANUAL FOR SUBMISSION OF INTERNAL AUDIT REPORT BY MEMBER
