Sub: Revision in STP INF515 Format

This is with reference to Exchange Circular Ref. No. NSE/INSP/64389 dated October 04, 2024 on "Revision in Contract Note Format".

The format of the STP IFN515 has been revised subsequent to discussions in Broker's Industry Standards Forum (ISF) and in consultation with SEBI. Accordingly, remarks of Mandatory Subsequence D3 (Amounts) - column 19A has been modified from "**To identify the brokerage**" to "**To identify the brokerage and other permissible charges**". The revised STP IFN515 format is attached as **Annexure I**.

All Members are advised to take note of the above.
