Report shall be submitted after approval from respective IT Committee	July 31, 2026

Trading members are requested to take note of Annexure 1.2 of Exchange Circular No. NSE/INSP/73792 dated April 17, 2026, regarding actions for non-compliances observed in periodic submissions made by Trading Members/REs related to submission of VAPT Report.

Further, trading members who have classified themselves as 'Exempted from CSCRF' (as per criteria/thresholds given in SEBI circular dated April 30, 2025) shall be required to provide a declaration on the member portal. The path for submission of the declaration is provided below:

Inspection → VAPT → Display VAPT Auditor Registration → Click on "New Auditor" → Under 'Member Category' select **Exempted** → (Member will be routed to a separate page) Submit the declaration
