Sub: SAT Order in the matter of Mr. Suresh Chinde Gowda

This is with reference to NSE circular no. NSE/INVG/32492 dated June 01, 2016 referring to SEBI order no. WTM/RKA /ISD /59 /2016 dated June 01,2016 restrained Mr. Suresh Chinde Gowda [PAN: AHVPG4424G] to buy, sell or deal in the securities market in any manner whatsoever, or access the securities market, directly or indirectly, till further directions.

Further, with reference to NSE circular no. NSE/INVG/33047 dated August 24, 2016 referring to SEBI order no. WTM/RKA/ISD/ 106 /2016 dated August 24, 2016 confirmed the directions issued vide the ad interim ex-parte order dated June 01, 2016 against Mr. Suresh Chinde Gowda [PAN: AHVPG4424G].

SAT now vide its order dated February 16, 2017 has set aside the confirmatory order dated August 24, 2016 with a direction to the WTM of SEBI to pass fresh order after hearing the appellant as expeditiously as possible. It is made clear that ad-interim ex-parte order dated June 1, 2016 shall continue to be in force till then.
