SEBI vide its order no. WTM/GM/SEBI/ERO/IMD/39/2017-18 dated August 08, 2017 has restrained following entities from accessing the securities market and have further prohibited them from buying, selling or otherwise dealing in the securities market in any manner whatsoever, either directly or indirectly and associating themselves, with any listed company or any public company intending to raise money from the public, till further directions.
