Sub: SEBI Interim Order in the matter of Prosperity Agro India Limited (“PAIL”)

SEBI vide its order no. WTM/GM/EFD/40/2017-18 dated August 08, 2017 has restrained following entities from accessing the securities market and have further prohibited them from buying, selling or otherwise dealing in the securities market, either directly or indirectly, till the directions for refund/repayment to investors are complied with, as mentioned above, to the satisfaction of SEBI and repayment completion certificate is submitted to SEBI and for a further period of four years from the date of completion of the refund, as directed above.
